5. Shielding: 5 mils tape shield
6. Rip Cord: Rip cord for ease of jacket removal
7. Overall Jacket: Polyvinyl Chloride (PVC) Jacket

UL rated construction can be used in Class I, II, and III, Division 2 hazardous locations per NEC Article 501 and 502. UL rated constructions with 3 or more conductors are listed for exposed runs (TC-ER) per NEC 336.10.
